## MERCIALYS PARTNERS MEDECINS DU MONDE

Mercialys has announced a national partnership with Médecins du Monde ("Doctors of the World") to allow the humanitarian association to have a presence at 27 of its shopping centers.

From April 16 to September 25, 2015, teams from Médecins du Monde will travel to the various shopping centers taking part in the scheme to provide information about what they do and encourage new long-term donors.

This partnership falls within the framework of Mercialys' Corporate Social Responsibility policy, with charitable associations playing a central role in the life of its shopping centers. Its long-term commitment to charitable associations is reflected by the creation of a "Maison des Associations" at its villages.services, in particular those at Niort and Clermont-Ferrand, which opened at the end of 2014.

The scheme was launched on April 16 in Fréjus and will continue at each of the group's partner centers throughout the summer period.

This new, distinctive form of retail consists of a retail walkway located in the center's outside car park, opposite the main entrance. Around 10 village.services openings are planned for between now and the end of 2015.
