RESPONSES TO WRITTEN SHAREHOLDER QUESTIONS FOR THE ORDINARY GENERAL MEETING OF APRIL 23, 2026

The Ordinary General Meeting of Mercialys shareholders was held on Thursday, April 23, 2026, at 10:00 a.m. The Board of Directors responded to the written questions submitted to the Company in connection with this General Meeting:

I. Question relating to the dividend

"Are you considering returning to a semi-annual dividend distribution through the payment of an interim dividend, and if so, under what conditions and within what timeframe?"

The Board of Directors determines each year the terms of dividend distribution. A return to a semi-annual distribution through the payment of an interim dividend, should it be considered, would be assessed in light of (i) results and cash flows, (ii) financing requirements, liquidity position and financial commitments, and (iii) its capital allocation priorities, in compliance with the legal framework and best governance practices. By way of reference, on Euronext Paris, annual dividend distribution remains the prevailing practice, with a more limited number of issuers opting to pay one or more interim dividends.
