You can subscribe to the e-notice service at any time <sup>(\*)</sup>.

You will automatically be e-mailed a notice of meeting containing:

- the date, the time and the location of the General Shareholders' Meeting,
- a direct link to the PLANETSHARES website,
- a reminder of your login information (*username - access code*).

On PLANETSHARES' home page, by clicking on "**Take part in vote**", you will be redirected to the VOTACCESS secure platform where you will be able to :

- obtain access to all documents related to the General Shareholders' Meeting,
- request an attendance card to attend the General Shareholders' Meeting which can be edited,
- vote on the resolutions,
- give proxy to the Chairman of the Meeting or to any other natural person or legal entity of your choice, irrespective of whether he/she/it is a shareholder,
- revoke or appoint a new representative.

## 1 - Connect

## 2 - Log in

Enter the **usual login credentials** (*username - access code*) you use to access your registered account, which have been printed for your convenience on the documents sent to you by BNP PARIBAS SECURITIES SERVICES and enter your password.

## 3 - Click on "Activate e-services"

Enter or confirm your e-mail address and click to subscribe to the e-notice service and receive all notices for the upcoming General Shareholders' Meeting by e-mail. It's that easy!

On that same screen, you can also manage your subscriptions to e-services, opt for paperless services to stop receiving any documents by post (*portfolio statements, transaction notices, credit notices...*). You will receive by email a notification provision through in PLANETSHARES in regard to electronical documents.
